

## 2025 Young Originals exhibition – Student artwork permission agreement

Dear Student Artist,

The Young Originals exhibition provides Western Australian public school students with the opportunity of a professional exhibition experience.

Your artwork, \_\_\_\_\_ *[insert title]* has been selected by your school for entering in the Young Originals exhibition. To qualify for judging and display in the exhibition, your agreement and permission is required for the following conditions and activities relating to the Young Originals exhibition.

1. You agree that,

your artwork is your own original work and that you are the sole creator of your artwork, and **that your artwork contains no material created by someone else.**

and that you are the sole creator of your contribution to the artwork, and that **the artwork contains no material created by anyone other than your co-creators.**

2. You understand that, if selected, the utmost care will be taken in relation to preparation, packing, transport, handling and display of your artwork for the duration of the Young Originals event. However, entry of your artwork is ultimately at your own risk and no insurance or compensation is available to you in the unlikely event that your artwork sustains damage as a result of the exhibition activities.
3. If selected, you give permission for your artwork to be reproduced and communicated for the purposes of running and promoting the Young Originals exhibition, including the following activities:
  - Entering your artwork into Young Originals
  - Judging of entries
  - Online cataloguing of entries via the Young Originals website for access by the public
  - Photographing and filming the exhibition at Spectrum Project Space ECU Mt Lawley
  - Developing promotional materials for the Young Originals in any format, including by the Young Originals sponsors: the Western Australian Secondary School Executive's Association (inc.); Sangora Education Foundation; Edith Cowan University; and the Department of Education WA
  - Developing and publishing educational online resources relating to the teaching of visual arts or design, for use in school classrooms.
4. If selected for exhibition and/or publishing, your artwork will be acknowledged with its title, your name, your school and an explanation of the artwork that you have provided to your teacher.
5. You retain all rights in your artwork (or to your contribution to a co-created artwork) other than the limited rights granted for the Young Originals in this permission form.
